OLD BUSINESS "Discussion and possible action"

- a) CTWSC CTWSC sent a request for rehearing to the El Paso Court of Appeals. We are awaiting their response. CTWSC wants to negotiate costs.
- b) CR3600 Line Loop Project The contractor is scheduled to mobilize equipment to the project site the week of January 17, 2022. Our November 2019 budget cost estimate for CR 3600 and FM 1113 was \$2,148,200 for the water line projects.
- c) FM 1113 Waterline Loop "See CR 3600 Line Loop Project"
- d) CR 3420 Pump Station Project The contractor has completed the testing and starting up procedures and the new pump station was placed into service on November 30, 2021. KWSC was notified of an overdue payment from Legion Development to Dakota Pump for the factory-built pump station. We have notified KWSC's attorney, who has provided the contractors who have notified KWSC of overdue payments. Paid 7 checks to Legion Development in the amounts of \$10,350.00, \$65,299.77, \$27,955.80, \$34,830.00, \$42,682.95, \$24,329.52 and \$244,989.00 totaling \$450,437.04 of the \$574,650 approved amount.
- e) Stone Oaks Elevated Storage Tank The contractor has completed the remaining punch list items and all final closeout documentation has been received. Paid 12 checks to Caldwell Tanks in the amounts of \$22,571.34, \$125,630.09, \$243,063.87, \$87,714.54, \$453,516.70, \$37,161.72, \$86,710.68, \$175,788.3.1, \$75,468.00, \$64,921.10 and \$87,129.25 totaling \$1,481,160.49 of the \$1,752,600 approved amount. Note: Bid from Caldwell Tanks came in at \$1,632,600.
- f) GIS Mapping for Distribution System: <u>Jones-Heroy Engineering is in the process of adjusting the digitized 'Phase 1' waterlines, flush valves, and line valves to match the field collected GPS points.</u>
- g) CCN Amendment Topsey WSC Overlap In February 2021, KWSC staff received approval from Topsey WSC for an overlapping CCN which will be required for water service to the proposed Northern Hills Phase 2-5 and Ryatt Ranch subdivisions. We received a final Notice of Approval from PUC on November 16, 2021, and the Coryell County recorded documents were filed with PUC on December 2, 2021, which completes the process.
- h) Georgetown GST Rehabilitation A Notice to Proceed was issued to Classic Protective Coatings for construction of the project effective December 20, 2021, which includes 120 calendar days for substantial completion of the work. The contractor is planning to mobilize to the site and begin the work the first week in February 2022. The March 2021 budget cost estimate was \$733,347 for the project.
- i) Highway 183 Extension On June 8, 2021, we met with KWSC staff to discuss the need for water service along Hwy 183 in KWSC's southern service area. We are in the process of reviewing prior engineering studies conducted to serve potential new development in this area and will provide recommendations and cost estimate for a proposed 'Phase 1" pipeline extension.
